Introduction

Our Interface uses cookies to distinguish you from other users of our Interface and the cookies allow us to determine the needs of every users. This helps us to provide you with a good experience when you browse our Interface and also allows us to improve our Interface.

The section below summarises the different types of cookies we use on our Interface, together with their respective purposes and provides you with the ability to manage these cookies.

Information About the Use of Our Cookies

Cookies are small files of letters, units and numbers that we store on your browser or the hard drive of your computer if you agree. The particulars contained in cookies is for the purpose of providing social media features, to provide the appropriate services and products to you, to allow us to improve your website experience and to make it more efficient to you. Cookies contain information that is transferred to your computer's hard drive.

We use the following cookies:

- **Strictly necessary cookies.** These are cookies that are required for the accurate operation and functionality of our Interface . These are the type of



cookies that cannot be switched off in our Interface. These are the cookies that resulted, among others, from logging in and filling in forms on the website. These cookies do not store any personal identification information of the users.

- **Analytical or performance cookies.** These are the cookies that help us to enhance the Interface and its functionality to the users. These cookies permit us to determine the number of visitors on the Interface, how the visitors are moving around on the Interface and to determine which pages are the most and least favored.
- **Functionality cookies.** These are the cookies that are used to remember the choices you made and tailor the website in order to provide an improved content for you. These cookies allow us to remember you when you return to our Interface.
- **Targeting cookies.** These are the cookies that track your actions, record your visits to our Interface and collect information and use the same to build interests in line therewith resulting to personalized ads making the Interface more relevant to you.
- **Tracking cookies.** These are the cookies collected and used to track and share your referral-related activities on our websites.

Please note that third parties (including, for example, advertising networks and providers of external services like web traffic analysis services) may also use cookies, over which we have no control. These cookies are likely to be analytical/performance cookies or targeting cookies.

Controlling Cookies
